ORDER ACCEPTING COMPLAINT AND GRANTING EMERGENCY TEMPORARY SUSPENSION

AND NOW,	this	10	day of	March	, 2015

WHEREAS, the Delaware Department of Justice through the prosecuting Deputy

Attorney General has filed with the Board of Veterinary Medicine a written Complaint and

Motion for Temporary Suspension; and,

WHEREAS, said Complaint and Motion allege that the Respondent, a licensed veterinarian, in her treatment of dogs Brooke and Bo, has engaged in activities which present a clear and immediate danger to the public health: performance of an improper surgical procedure; unnecessary use of sedation; improper use of medication; use of a sedation reversal medication not approved for canines or in connection with sedatives used by Respondent; Respondent's release of the animals to their owners while still unconscious or in distress; negligence in the care of Bo which caused the dog's death; Respondent's treatment of Brooke during Respondent's licensure suspension; and negligence in the care of Brooke such that Brooke experienced blindness and seizures which ultimately led to her being euthanized; and

WHEREAS, the allegations if substantiated at a formal hearing constitute the illegal, incompetent or negligent practice of veterinary medicine, in violation of 24 *Del. C.* § 3316(a)(3); and

WHEREAS, Respondent and/or her legal counsel was given at least 24 hours' written or oral notice so that she or her counsel could file a written response in opposition to entry of an

Order of Temporary Suspension together with a copy of the Complaint in compliance with 24 Del. C. § 3317(c); and Respondent did not file an Answer to the State's Complaint; and WHEREAS, after reviewing the allegations in the State's Complaint in toto, said Complaint highlights the serious and dangerous nature of Respondent's offenses. Further, the undersigned have an obligation to ensure the public health, safety and welfare is protected. After due consideration of the Complaint and the Motion, the Secretary of State or his designee with the concurrence of the Board President or her designee have therefore determined that the available information is sufficient to support the entry of an Order temporarily suspending Respondent's license to practice veterinary medicine in the State of Delaware in that there is a reasonable belief that Respondent's continued practice presents a clear and immediate danger to the public health, safety and welfare;

IT IS SO ORDERED this 10 day of March , 2015:

- 1. That the Motion for Emergency Suspension of Jaine Weise's license to practice as veterinary medicine (License No.: N1-0002192) is granted;
- 2. That Jaine Weise shall be served with a copy of this Order as provided in 24 Del. C. § 3317(c) and notice shall be provided to all other agencies listed therein;
- 3. That Complaint Nos. 28-01-15 and 28-03-15 are accepted by the Board as the Formal Complaint and shall be assigned to a hearing officer to be scheduled in accordance with 24 *Del*. C. § 3317(c) and 29 *Del*. C. § 8735(v)(1)d to hear evidence related to the Formal Complaint; and

4. That pursuant to 24 Del. C. § 3317(c), Dr. Weise may request an expedited hearing provided that the Board receives the request within 5 calendar days of the date Dr. Weise is notified of this Order.
